

**CITY OF BRISTOL
REGULAR MEETING**

Mon., Feb. 10, 2020

6:30 P.M.

Chairman Durwood Stewart called this meeting to order with Council-members Tom Clemons, Charlotte Shuler, Jonathan Allen, and Vice-Chair Margaret Rankin present. City Clerk Robin Hatcher, Mayor Heather Willis, and Attorney D. Jackson Summers were also present.

Sergeant Mitch Willis offered the opening prayer. Mr. Brigham Shuler led the Pledge of Allegiance.

Councilman Clemons moved to approve the agenda, seconded by Vice-chair Rankin, carried by all.

Councilman Clemons moved to approve the minutes, seconded by Vice-chair Rankin, all voted in favor.

Councilman Clemons moved to approve the monthly bills for payment, seconded by Vice-chair Rankin, approved by all.

Mr. John Russell and Ms. Patti Miller-Crowley spoke to the Council about FEMA Community Recovery Assistance and the benefits of participating in a VISTA program.

Mr. Curtis Battles invited the Mayor and Council-members to participate in the Black History Parade and Festival to be held on Feb. 22, 2020.

Councilwoman Shuler moved to approve a Septic Waste Disposal Agreement with Doyle Brown contingent upon his acceptance of the Agreement, seconded by Vice-chair Rankin, carried by all.

Mr. Teddy Eubanks requested a 90 day extension to comply with his cited code violations. Councilman Allen moved to grant a 30-day extension to Mr. Teddy Eubanks, with consideration of an additional extension to be contingent upon him showing significant progress in abating some of the items listed on his citation. Councilman Clemons seconded this motion. All voted in favor.

Vice-chair Rankin moved to establish that the Council's intent regarding the \$600 annual compensation for the Mayor and Council-members, as approved by a referendum vote on Nov. 12, 2019, is to reimburse for expenses incurred in performing duties, and not intended to be a salary subject for inclusion in the Florida Retirement System (FRS), and to be compensated \$50 monthly rather than one payment annually. Councilman Allen seconded this motion. Motion passed unanimously.

The Council, in general discussion of city ordinances, identified the need to address City of Bristol Ordinance #87-1 related to Animal Control and expressed an interest in utilizing a VISTA Volunteer to research funding resources and assist in developing an animal control program for the City of Bristol.

Due to Labor Day holiday falling on Mon., Sept. 7, 2020, by general consensus, the Council set the Sept 2020 Regular Council Meeting for Tues., Sept. 8, 2020 at 6:30 p.m.

There being no further business, Vice-chair Rankin moved to adjourn, seconded by Councilwoman Shuler, all voted in favor. Meeting adjourned at 8:30 p.m.

LCSB was adjourned by motion of School Board Member Darrell Hayes, second by School Board Member Kyle Peddie, motion carried.
